This position will also provide key technical support to research that will lead to improved beneficial management practices and assist in the delivery of agri-environmental policy and programs. Duties include:

- Using survey grade GPS and UAV technology to develop topographical surveys in support of land management and soil conservation best management practices as a component of the PEI Department of Agriculture and Land's standard extension services and the technical commitment to the environmental component of the Federal/Provincial Canadian Agricultural Partnership Program;
- Use of GIS, CAD, and Photogrammetry software for processing survey point and UAV data to produce soil conservation plans and generate points for layout of soil conservation structures on farm;
- Schedule maintenance and repair work on the Sustainable Agriculture Section's survey instruments and field equipment including data loggers, weather stations, receivers, radios, all terrain vehicles and trailers;
- Maintain the Section's archive of digitized plans;
- Assist with the annual audits for the Alternate Land Use Services Program;
- Assist in the preparation and execution of annual work plans for applied research plots or trials in the Sustainable Agriculture Section, including possible projects in soil conservation, waste management, nutrient management planning, water resource management, integrated pest management, and agroforestry;
- Provide general labour or technical support for staff in the Sustainable Agriculture Section, including nutrient management planning, water resource management, soil conservation, integrated pest management, and others as they arise;
- Other duties as required.

- Must have a Bachelors of Science Degree in Agriculture, Bio-Environmental Systems Management, Environmental Science OR a related discipline with a strong background in environmental science, soil and water management, water quality management, surveying and geographical information systems;
